Town breaks ground on Joralemon Park bathroom facility

Independent Media COEYMANS project that first got its start 20 years ago is finally coming to fruition.

Town and county officials broke ground last Tuesday on the permanent bathroom facility that is being built at Joralemon Park.

The town began pursuing permanent bathrooms at the park back in 2001 and got as far as installing a well and septic system, but the project stalled. Former Town Councilman Frank Stanton, who was on the board 20 years ago, joined the groundbreaking ceremony this week.

Town Supervisor George McHugh was also on the board at the time and said it was gratifying to see the project finally getting done.

"Back in 2001 I was on the town board with Frank Stanton and we made an application for a grant

overdue."

to get a well and septic put in in preparation for bathrooms," McHugh said. "The well and septic were put in and nothing has happened since, until now. Thankfully, we will finally make it happen."

Construction on the bathrooms began Monday and is expected to be finished by the middle of September.

The facility, which will be constructed of cement and block, will include a men's and ladies' bathroom, with a utility room in between. There will be two stalls in the ladies room and one stall and one urinal in the men's

room, with a baby changing station in both.

Joralemon Park currently uses Porta Potties.

Albany County Executive Daniel McCoy said the facility will be a benefit for the town and the people who utilize the park.

"It's really going to

be a convenience for the people who come to the park," McCoy said. "Not everyone likes using an outhouse and it will be easier for kids and for changing babies. It's long

McCoy commended the town board for its vision in improving the

"It's about quality of life for our residents and giving them opportunities to come out here and enjoy the park," McCoy said.

The cost of the construction project will be paid primarily through federal funds given to the town through the American Rescue Plan Act, or ARPA, which was established in the wake of the COVID-19 pandemic.

"The cost is \$360,000 for the bid," McHugh said. "The funds are primarily coming from our ARPA monies, and whatever balance is left over - if there are change orders or things like that we will use fund balance from the town budget."

ARPA funds can be used for a variety of purposes, and improving hygiene systems is on the list of approved uses.

vere," Voronko continued. Engel, the Class of 2023 salutatorian, urged his fellow graduates to move into the future fearlessly, and to pursue their passions without hesita-

He said that in the future, he wants to be able to look back on his life and know that he worked hard goals.

"Put those goals into an envelope — or notes section on your iPhone, because who uses paper anymore anyway? — and revisit those goals from time to time. Having something personal to work towards is the ultimate motivator."

feds before we allocated that money and we made sure through our engineers and through ARPA that we could use the money for this purpose,' McHugh said.

Albany County Legislator Zachary Collins,

R-Coeymans, said the bathroom facility is part of an overall improvement plan for the park, which has seen numerous renovations over the past

"When I was on the town board we started this process. We already put in playground equipment,

we paved the tennis court and added the basketball court, paved the entrance, and this will be the cherry on top," Collins said.
"This shows we really care about quality of life and providing the residents with a nice place to

go.' The park improvements will benefit town residents and others who come to the park, Deputy Town Supervisor Brandon LeFevre said.

"It's a great park people come here from all over the Capital Region and surrounding states," LeFevre said. "I saw a [license] plate here from

Georgia today. The disc golf really brings people together and it's a great way to get people outside and enjoying the outdoors.

The town has another bathroom facility project slated to begin later this summer at Coeymans Landing. A groundbreaking for that project is scheduled for August, with construction expected to be completed in November.

The Joralemon Park project is slated for completion in mid-September.

"By the end of November, both bathrooms should be fully functional and done," McHugh said.

"Our transportation department has received multiple calls about


Becky being a positive influence on their child and teaches them the proper emergency procedures of a bus," according to a statement from the department.





Bear spotted in village, state offers tips to stay safe

A black bear was sighted in the village June 13, Mayor Bill Misuraca announced in a statement on social media.

There has been an uptick in bear sightings in the region, including in nearby Columbia County and elsewhere.

The bear that was spotted in Ravena was seen crossing the road and disappeared into the woods.

'One of our residents was walking down Railroad Avenue just a few minutes ago and encountered a young black bear! It crossed the road headed towards the railroad tracks," Misuraca said.

Most bears are not aggressive, but vigilance is still recommended, Misuraca said.

'99.9% of the time they're not going to bother you, but this was kind of wild being broad daylight right there, so just keep an eye out and pay attention to your surroundings," Misuraca added.

Black bears are most active in spring and summer, and with the increase in sightings in populated areas, the state is offering tips to stay safe if you do run across one.

New York State Detal Conservation Commissioner Basil Seggos announced that the DEC is joining the BearWise campaign as a cooperative member state.

BearWise was developed by biologists from state conservation agencies across the U.S. to ensure people, regardless of location, learn to live responsibly with bears.

Using the "BearWise basics," residents are encouraged to take simple steps at home or when recreating outdoors to avoid negative interactions with black bears.

"DEC biologists and technicians respond to hundreds of human-bear conflicts each year that are nearly all preventable," Seggos said. "As New Yorkers head into the summer months, which is a busy time for bears, DEC encourages the public to practice the Bear-Wise basics by removing things bears find attractive like pet food and trash to help reduce the potential for negative interactions."

Black bears are most active throughout the spring and summer months and can be attracted to human-created food sources, especially during dry weather periods when natural food sources are

The BearWise campaign recommends peopartment of Environmen- ple take six basic steps to avoid attracting bears to areas around homes or neighborhoods:

• Never feed or ap- 844-332-3267). proach black bears:

- Secure food, garbage, and recycling;
- Remove bird feeders
- when bears are active; • Never leave pet food
- outdoors;
- Clean and store grills and smokers; and
- Alert neighbors to bear activity.

BearWise also recommends six basics when recreating or vacationing in bear country:

- Stay alert and togeth-
- Leave no trash or food scraps behind;
 - Keep dogs leashed;
- Camp away from dense cover;
- Secure food and cook as far away from tents/living quarters as possible;
- · Carry bear spray, know how to use it, and know how to respond if you see a bear.



Queen and Town: A chronicle of resilience, redemption and responsibility

Horses of Unbridled



Queen of the Bayou and Town on Fire are two Thoroughbred mares gracing the pastures of the Sanctuary at Unbridled.

They radiate with beauty and vitality. Their soulful eyes invite visitors and volunteers to a world of companionship with horses. Whether during creative sessions, reading times, study breaks or grooming routines, Queen and Town provide emotional support to the humans who interact with

Gentle and always attentive, they are a repository for secrets, sorrows and joys, free from judgment. Despite their past filled with despair, the mares are always eager to make new connections.

With Queen and Town, we bear witness to the incredible ability of horses to forgive and flourish, even after enduring severe hardship. As you journey through the poignant tale of their rescue, allow these extraordinary creatures to touch your heart and see the importance of respecting them as fellow beings with their own intrinsic worth. You may find yourself transformed into an advocate, a spark igniting change in the world of horse racing.

Queen of the Bayou was born in Louisiana on March 12, 2008. At two years of age, her breeder sent her to auction in Florida. She sold for \$17,000. During training, Queen showed immense promise. Her powerful and elongated stride, accompanied by a swift turn of foot, covered vast stretches of ground.

As she prepared for her inaugural race at Louisiana Downs, anticipation built, and Queen did not disappoint. On Sept. 2, 2011, Queen won in her first outing. Celebrating with her in the Winner's Circle was a part-owner named Aaron Kennedy.

However, a nagging ankle injury necessitated Queen's retirement from racing. By February 2012, at the tender age of four,

Oueen was expecting her first foal. In all she would carry and nurture four for

Kennedy's Wallace Lane Thoroughbreds. In 2017, Kennedy found Queen a new home. For a time she was cared for, until she reappeared in George Baker's slaughter-bound feed-

lot in Stroud, Oklahoma. Once vibrant and spirited. Oueen had become emaciated and severely lame, her prospect of rescue dishearteningly grim. Despite thousands of social media shares pleading for her life, no one seemed interested in saving her.

On the other hand, Town on Fire, an 18-yearold mare still in excellent health, had spent her years producing Quarter horse offspring. When she became unwanted, she too was discarded at the same slaughter-bound feedlot. It's estimated that two-thirds of all horses sent to slaughter are Quarter horses, many of them cast-offs from the rodeo or racing industries.

The paths of these mares intersected when Unbridled rescued them and altered their destiny from a livestock truck bound for Mexico to a soft spacious trailer ride to Sanctuary in New York. Unbridled's mission extends beyond mere rescue; they strive to reconnect these horses with their past connections, in hopes of securing financial and transformative support for the rescued animals.

Queen of the Bayou was lucky. Her past had intertwined with Aaron Kennedy, her former owner and unexpected hero. When Kennedy learned of Queen's plight, he swiftly and generously shouldered all expenses to


decades in comfort. Town on Fire's story was less fortunate. Despite being home-bred at millionaire Satish Sanan's Padua Stable, efforts to reach out to her past connections have been unsuccessful. Despite multiple attempts to contact Sanan via phone, email and letter, a response remains elusive.

Sanan, at the peak of his horse racing involvement, owned farms in Ocala, Florida, and Lexington, Kentucky. He has publicly claimed to have invested over \$150 million into the sport he loves, producing several Breeders' Cup winners like Vindication, Cajun Beat, Cash Run, and the great Curlin, the 2007 Breeders' Cup Classic victor and Horse of the

Outside the racetrack, Sanan is a renowned figure in the business world, serving as chairman and CEO of Inspirata Inc., a leading provider of cancer informatics and digital pathology solutions. These accomplishments underscore the potential for greater accountability, especially when it comes to the well-being of his horses. Whether they be successful like Curlin or not, they all bear his name.

This story is not just about Queen and Town; it's a clarion call for responsibility, compassion and advocacy. The contrast between Kennedy and Sanan is not just about individual responsibility but also about accountability. We must not only care for these animals when they are in use and service to us, but also be answerable for our actions and decisions that affect them and help them when

they need a lifeline. The world needs more individuals like Aaron Kennedy, willing to make provision for the horses they know. Kennedy's recent appointment in June 2023 as president of Des Moines advertising agency Flynn Wright, the first non-Flynn to assume this position, reflects his dedication and commitment. His journey from account coordinator to president in just 23 years highlights



State takes steps to protect pollinator health

ALBANY — New York State Agriculture Commissioner Richard A. Ball recently highlighted actions the state has taken to promote and protect pollinator health across New York.

The state released its updated Pollinator Protection Plan, outlining the coordinated work of state agencies to enhance pollinator health, including beekeeper registration, outreach and education programs; continued support of the New York State Beekeeper Tech Team; improved landscape management at state facilities and along roadways to provide increased habitats, and more.

'Pollinators play a critical role in our agricultural industries statewide," Ball said. "We depend on our pollinating populations like birds, bees, butterflies and other insects to help

omy. Together with our fellow agencies, our partners at Cornell University, and our hardworking farmers, we are committed to conserving and growing our pollinator populations to ensure a strong future for agriculture and our environment in New York."

According to information from the U.S. Department of Agriculture National Agricultural Statistics Service, pollinator services contributed to the production of \$469.8 million worth of crops grown in New York and add \$29 billion in value to crop production nationally each vear. New York's ability to produce crops such as apples, cherries, strawberries, pumpkins and squash relies heavily on the presence of pollinators.

"Honeybees and other pollinators play a critical role in New York agriculture and our food system, pollinator population," said New York Farm Bureau President David Fisher. "New York Farm Bureau has long supported the Integrated Pest Management program as an effective way to reduce pesticide use and take into account the needs of pollinators. New York Farm Bureau looks forward to continuing working with the New York State Department of Agriculture and Markets to reach the best possible outcome for pollinators and our state's important agricultural system."

Over the past several years, New York state has taken steps to promote honeybee health and better protect pollinators statewide. In 2022, the Department of Agriculture and Markets launched a beekeeper registration program to better help beekeepers maintain their

registered 1,625 beekeepers who are managing nearly 31,500 colonies throughout New York

state. Additionally, the department's honeybee health improvement program asks beekeepers to indicate if they intend to sell bee colonies to monitor colony movement across and between state borders. To ensure that the department can properly inspect bee colonies, all New York state beekeepers must complete the registration form and renew their registration annually at no charge. Register at beekeepers.agriculture. ny.gov/registration.

The Pollinator Protection Plan has also continued to fund, through the state budget, the development and expansion of the New York State Beekeeper Tech Team at Cornell University, which works diour crops grow and support the agricultural econation which is why it is importate colonies in a healthy conamination and to maintain a healthy dition, which has since improve honeybee health, use of these pesticides en-

In January 2022, the Department of Environmental Conservation took action to limit the unrestricted use of certain pesticides that can impact bee and other pollinator populations. In effect as of January 2023, certain products containing the neonicotinoid (neonic) insecticides imidacloprid, thiamethoxam and acetamiprid are now classified as "restricted use" to ensure applications are limited to trained pesticide applicators in specific

ables DEC to collect new data to determine where, when, and how they are used, as well as their potential impacts.

Additionally, ners at the Department of Transportation (DOT), Thruway Authority, and Office of General Services (OGS) continue to enhance pollinator habitats and employ best landscape management strategies on state land and along road-

"Pollinators are critical to the health of New York's environment and must be protected from threats like habitat loss. parasites, climate change, and pesticide misuse,' DEC Commissioner Basil Seggos said. "Working with partners across the state, DEC is committed to promoting best practices to maintain healthy pollinator populations and safeguard the future of our

Bethlehem Police equipped with body-worn cameras

BETHLEHEM — On June 19, the Bethlehem Police Department completed phase one of a large-scale project that has equipped officers in the town of Bethlehem

with body-worn cameras. The body-worn camera project originated as one of Police Chief Gina Cocchiara's long-range goals for the department in 2020, as well as one of the core recommendations of the Police Reform & Collaborative Plan. The move was supported by the members of the Bethlehem Police Department.

"The implementation of body-worn cameras will improve police accountability and adds a layer of trust, while inevitably lowering reports of alleged misconduct and community complaints," Cocchiara said. "There is a cost saving component from reduced complaints against officers, and the reduced time required by the police administration to resolve such complaints. The cameras can be used as a training tool and will provide useful evidence for court cases".

The policy for the use of the cameras and the video footage was derived from multiple sources.

First, the policy is guided by specific state guidelines set forth by the Division of Criminal Justice Services that regulates the standards and "best practices" that police departments should meet when utilizing body-

worn cameras Additional

Additionally, members of the Bethlehem Police Administration have met with other police agencies that are currently using body-worn cameras and have considered their recommendations on what aspects assist in creating a strong policy.

Lastly, the Police Department Administration reviewed the policy with members of the Police Community Advisory Group and considered their recommendations as well.

The goal of the process was to create a policy that would strengthen trust between the police department and the community, increase transparency and accountability,

and be supported by both the public and the police officers.

The body-worn camera policy is now available on the Town of Bethlehem web page along with other department policies.

"I am so pleased that our outstanding police officers are now equipped with body-worn cameras," said Town Supervisor David VanLuven. "The cameras advance our collective goal of further increasing transparency and accountability, supporting our officers, and protecting all community members."

Phase two of the project is to replace the aging mobile car camera systems in the patrol vehicles

What you need to know about ticks

Tick season is here, but there are ways to protect yourself.

There aren't many reasons to dislike spring and summer, but ticks are one. The blacklegged tick, aka deer tick, becomes active once the temperature hits about 40° F.

It is a highly unusual organism, a spirochete (spiral-shaped) that can spread six different diseases through multiple a bacteria, a virus and a parasite — in the second year of its twoyear life cycle. Lyme disease, anaplasmosis, ehrlichiosis and babesiosis are the most prevalent illnesses in our area.

This year, the ticks are expected to be especially active and numerous, the product of a warmer climate and the increase in animal host populations (deer and white-footed

According to Dr. Ronald Pope, vice president of Medical Services at Columbia Memorial Health, in the 12 months from March 2022 through February 2023, the CMH lab diagnosed 343 cases of Lyme, 157 of anaplasmosis, 118 of ehrlichiosis and 109 of babesiosis. Although there are Lyme diagnoses throughout the

year, diagnoses rise in April and peak in August. The other three diseases spike beginning in May, peaking in June and again in October.

Experts agree the best approach to ticks is to avoid a bite altogether. The Cornell Cooperative Extension, Environmental Protection Agency (EPA) and Centers for Disease Control (CDC) websites, among many others, all offer advice.

Simplified, this includes:

- GO LONG: Wear long pants, a long-sleeved shirt and high socks. Also, wearing light colors makes tick-spotting easi-
- TUCK: Tuck your shirt into your pants and your pant bottoms into your socks, to close off entry points
- **DETER:** To ward off ticks, you can treat clothing with Permethrin or spray on Picaridin or, to go natural, Lemon Eucalyptus oil. (A full list of effective products can be found on the EPA web-
- AVOID: Ticks are most prevalent in brushy, wooded and high-grass areas. Avoid these or, when hiking, stick to the middle of the trail.

• CHECK: Frequently, check your clothes, yourself and your pet for ticks, hoping to remove them before they embed.

REMOVE: The longer a tick is attached, the greater the chance of disease transmission. You can simply pick off a tick that is not embedded. without risk. But, tempting as it is to remove an embedded tick by hand the moment you spot it, don't, as you'll increase the risk of disease transmission. Use a sterilized fine-tipped tweezer, pull upwards, don't twist or

• DOSE: It takes up to 36 hours for a tick to transmit Lyme. So, the CDC recommends that in areas like ours, within 72 hours of removing an embedded tick, you take a single, high dose of doxycycline. The symptoms of tick-borne diseases make diagnosis "tricky," according to CMH infectious disease specialist Manuel Revuelta. Symptoms overlap with many other conditions, including vitamin D deficiency. gout, celiac and other autoimmune conditions, and the available tests are notoriously inadequate.

Nevertheless, Dr. Revuelta says patients should seek medical advice if they have symptoms, as tickborne illnesses can have serious consequences if left untreated. Symptoms of Lyme, anaplasmosis, ehrlichiosis and babesiosis all include a feeling of general malaise or flu-like symptoms, headaches, fatigue, fever, rash, chills, sweats, nausea or loss of appetite, and, occasionally, confusion.

The dramatic increase in tick-borne disease diagnoses in the past 20 years has spurred greatly needed research into better diagnostic tools and vaccines, although experts lament the inadequacy of funding in New York state for education and research. The efforts are primarily directed at Lyme disease.

A partnership of the Department of Health and Human Services (HSS) and the Steven & Alexandra Cohen Foundation recently launched the LymeX Diagnostics Prize to accelerate the search for better tests, and in 2023 it funded 10 groups with promising approaches to Lyme diagnosis.

At the Cary Institute of Ecosystems Studies in Millbrook, Dr. Richard Ostfeld, a disease ecologist, and others are exploring the biological control of ticks with an environmentally safe and effective means of controlling ticks using a native fungus. Metarhizium anisopliae, a fungus widespread in local soil and leaf litter, is known to attack and kill or weaken ticks.

Under consideration is spraying forest understory vegetation with a fungus solution in the fall and delivering the fungus to the nesting area of the host white-footed mouse.

A number of vaccines

are also under development. At MassBiologics of UMass Chan Medical School, researchers have developed a human vaccine that delivers a monoclonal antibody into ticks when they bite that neutralizes the bacterium that causes Lyme. The vaccine conveys immunity almost immediately.

A vaccine invented by a partnership of Pfizer and Valneva will require three doses, induces the development of antibodies, and is entering Phase 3 human trials, with a goal of coming to market in 2025.

At the Yale School of Medicine, researchers have developed a vaccine that, using mRNA technology, recognizes a tick's saliva, weakens the tick's ability to stay attached for the 36-plus hours needed to transmit the disease, and makes it easier to pull a tick off.

Moderna recently announced it is exploring two Lyme vaccines, using the mRNA technology employed in Moderna's COVID-19 vaccine.

There are also developments underway for treating Lyme disease. Currently, broad spectrum antibiotics are used, which have drawbacks including that the drugs kill not only the Lyme-causing bacterium B. burgdorferi but also damage organisms (gut microbes) important to a patient's health.

Recently, a team at Northeastern University discovered that an antibiotic, hygromycin A, developed in 1953 but abandoned because it was effective only against a few bacteria, was very effective against B. burgdorferi; Now what was perceived as a weakness of the drug is seen as a benefit. The drug does not affect gut microbes or other healthy bacteria. The drug is being studied as a targeted therapeutic for Lyme disease.

Research is also underway into the use of stem cell therapy to reduce the severity of Lyme disease symptoms and promote the repair of tissues damaged by the bacterium, particularly for patients who have not responded well to other treatments.

Finally, a few words in favor of ticks and to remind us of the interconnectedness of all life.

Ticks are an important food source for some reptiles, amphibians, birds (including wild turkeys) and opossums. (Some people raise guinea fowl because they eat ticks and thereby reduce the population.)

Accordingly, scientists study tick populations for indications of ecosystem health. To take two examples: a low tick population can indicate that predators of the small animals that host ticks may be out of control; and, since healthy snakes eliminate thousands of ticks by eating the small mammals on which ticks feed, an increase in ticks may suggest a problem within the snake population.

And ticks serve the evolutionary purpose of controlling the population of certain animals. By transmitting their illnesses to their hosts, ticks cause weaker and older animals to die, promoting the natural selection process.

A one-hour program recently hosted by state Sen. Michelle Hinchey, D-41, and available on her Facebook page covers the areas of prevention, diagnosis and treatment through four brief presentations by ecological and medical experts.

DEC adopts new fishing regulations for striped bass in marine waters

The New York State Department of Environmental Conservation reannounced the cently adoption of new regulations in the state's marine waters for recreational Atlantic striped bass fishing.

The new recreational slot limit of 28 to 31 inches takes effect immediately and is set as required by the Atlantic States Marine Fisheries Commission (ASMFC) to reduce recreational harvest. The recreational slot limit in the Hudson River north of the George Washington Bridge remains 18 to 28

New York state works with the ASMFC and all East Coast states under the Atlantic Striped Bass Interstate Fishery Management Plan. On May 2, the ASMFC Atlantic Striped Bass Management Board approved an emergency action to implement a 31-inch maximum size limit for the striped bass recreational fishery for 2023. This action was taken in response to the large increase in recreational harvest of striped bass in 2022, and repeated years of poor reproductive suc-

The new slot limit is intended to protect a large proportion of the remaining adults to allow them to contribute to future spawning and stock rebuilding. ASMFC will continue to monitor harvest and success of spawning stock rebuilding, and if it deems necessary, may extend the emergency action for two additional periods of up to one year each.

New York's failure to implement the 28- to 31inch slot limit for recreational striped bass fishing in marine waters would

place the state out of compliance with ASMFC requirements and could result in the closure of New York's recreational and commercial striped bass fisheries. Henry Allan "Harry" Ironside was a Canadian-American Bible teacher, preacher, theologian, pastor and author who pastored Moody Church in Chicago from 1929 to

It is said that Harry Ironside was one of the most prolific Christian writers of the 20th century and published more than 100 books, booklets and pamphlets, many of which are still in print. He also wrote several hymns including "Overshadowed," "His Grace Proclaim" and "The Wonder of His Love to Me."

One editorial reviewer wrote in a 2005 republication that, "Ironside's commentaries are a Christian standard and have stood the test of time."

In his comments on Isaiah 57, Dr. Harry Iron-

side shares this true story: "Years ago, before the First World War, Professor Stroeter, a wellknown prophetic teacher in Germany, would travel through the country giving lectures and using charts to explain the dispensations. His meetings attracted the attention of the German Emperor, Kaiser Wilhelm, who despite his many idiosyncrasies, was quite a Bible student himself, and would deliver sermons in the palace chapel on many occasions. One day the emperor invited Professor Stroeter to his royal mansion so that he could have a personal session to learn more about the information the professor had been teaching. The professor was taken into the library and he began to spread his charts out on the table. The emperor listened closely as he pointed out various prophetic stages that led up to the glorious Second Coming of the Lord."

"After a lengthy conversation the emperor said, 'Do you mean to say that Jesus Christ is coming back literally, and when He returns all the kingdoms of the world are going to be destroyed and He will set up His kingdom on the ruins of them all?' Professor Stroeter said, 'Exactly, your Majesty.' The emperor backed away with a look of disappointment and said, 'Oh no, I can't accept that! This would interfere with all of my plans!"

What an honest but troubling admission from a man who professed to be a student and teacher of the Bible. There are indeed many interpretations and opinions about what the future may bring, but Christians can agree there is coming a day when this world will be no more

and God will establish His heavenly kingdom forever.

We look around and notice that many people are working hard to build their dreams. I know individuals that are making plans 10, 20 and even 30 years in the future, but are these divine blueprints that God has drawn? Have you known or heard about individuals that had their lives all mapped out, but were suddenly taken out of this world at a young age?

June is Pride Month

Celebrate and raise awareness for LGBTQ equality

Pride Month is currently celebrated each year in June to honor the Stonewall Uprising, also known as Stonewall Riots, which took place in the Greenwich Village area of Manhattan. In the early morning hours of June 28, 1969, New York City Police raided the Stonewall Inn, a popular gather place for the city's lesbian, gay, bisexual, transgender, and queer or questioning (LGBTQ) community. Citing an existing statute, commonly referred to as the "masquerade law," police targeted individuals for arrest who were not wearing at least three articles of clothing that conformed to apparel associated with the sex they were assigned at birth. Fed up with years of outdated and unjust laws, police harassment and persecution, the patrons at the club stood up for themselves, resisted arrest and demanded their civil rights. The raid sparked a series of violent clashes between police and

The first Pride March was organized for June 28, 1970, the anniversary of the raid. The march started at Christopher Street and ended in Central Park with thousands of peaceful protesters participating. The uprising and subsequent march were the first steps in a movement to eliminate laws and practices that singled out and discriminated against people who identify as LGBTQ in the United States.

protesters that lasted six days.

Since this first event, cities across the country and around the world have hosted pride parades, parties, picnics and other celebrations to commemorate

Stonewall. Ahead of the 30th anniversary, in June 1999, President Bill Clinton issued a presidential proclamation officially recognizing Gay and Lesbian Pride Month.

And on June 24, 2016, the National Park Service established the Stonewall National Monument which is located in Christopher Park across the street from the historic Stonewall Inn. The Inn itself is a National Historic Landmark and State Historic Site. It is also a privately-owned establishment and a working bar.

Pride Month isn't only a celebration of the freedom to express one's authentic self, but also serves to increase awareness of the need for equal justice and equal opportunity for people of the LGBTQ community.

DEC: Pheasants will be available for 2023 seasons

The New York State Department of Environmental Conservation has announced that the fall 2023 pheasant season will proceed as planned.

After the loss of the pheasant flock at DEC's Reynolds Game Farm earlier this year due to an outbreak of highly pathogenic avian influenza (HPAI), DEC is acquiring ring-necked pheasants from a commercial hatchery to supplement fall upland bird hunting opportunities around the state.

Every year, DEC releases 30,000 pheasants on more than 100 properties that are open to the public for pheasant hunt-

"Pheasant hunting serves as an introduction to hunting for many New York hunters," said **DEC Commissioner Basil** Seggos. "DEC was devastated by the loss of the state's breeder flock this spring and is grateful to be able to offer the pheasant program this fall and beyond."

New York does not have sufficient habitat quantity on a large landscape scale needed to support a wild, self-sustaining pheasant population, so the chance to harvest pheasants on publicly ac-

cessible lands relies on DEC's pheasant propagation program.

Pheasant hunting provides excellent opportunities to engage new hunters of all ages and to re-engage people who no longer hunt. In this way, the pheasant propagation program is an important hunter recruitment tool and many of these birds will be distributed to organizations hosting sponsored pheasant hunts for youth, people with disabilities, women and novice hunters.

Both young (8-12 weeks) and adult birds will be received at Reynolds Game Farm over the coming weeks and raised until they are ready for stocking at locations around the state. DEC will continue to follow existing HPAI protocols to protect the flock and remains committed to producing and releasing pheasants in 2023 and beyond.

Working widow seeks to maximize **Social Security benefits**

Dear Rusty:

I was widowed years ago and, when I approached age 60. I looked into Social Security survivor benefits based on my late husband's record.

He started receiving Social Security shortly

before he died at \$1,200 per month. My income at age 60 was \$42,000 and, since Social Security would keep \$1 for every \$2 above the limit (around \$15,000 at that time), I did not apply.

Next year I will reach my full retirement age of 66½, but I plan to work until I am 70. Will I be able to receive full survivor benefits next year if I continue to work? I plan to switch to my own Social Security benefit at age 70, which will be higher than my husband received.

Since I am waiting to apply for survivor benefits, will there be an increase in the amount I receive? I am a municipal employee and when I retire, I will collect from the state retirement system. I paid into the state retirement system and also paid Social Security taxes, so will my state pension have any impact on my Social Security?

Signed: Still Working Dear Still Working:

Congratulations having an excellent strategy for maximizing your survivor benefit as well as your personal SS retirement benefit. Once you reach your full retirement age (FRA) next year, you are no longer subject to Social Security's "earnings test" and can collect Social Security benefits without those benefits being affected by your work earnings.

Your surviving spouse benefit will be more because you are waiting until your full retirement age to claim it. At your FRA you can claim your full survivor benefit from your deceased husband (without reduction) and collect only that while still allowing your personal SS retirement benefit to grow to maximum when you are 70. Then, at age 70, you can switch from your smaller survivor benefit to your maximum SS retirement benefit and collect that higher amount for the rest of your life.

Essentially, your survivor benefit reaches maximum at your FRA and your personal SS retirement benefit reaches maximum at age 70.

Note that you should apply for your benefits a couple of months before you wish them to start. For example, if you reach your FRA in May of next year you can apply for your survivor benefit in


February or March, specifying that you wish your survivor benefit to begin in May 2024 at your full retirement age. Just be sure to emphasize that you are applying only for your survivor benefit and wish your personal SS retirement benefit to continue to grow by earning Delayed Retirement Credits (DRCs) until you are 70.

You cannot apply for your survivor benefit online, so you will need to call Social Security, at either the national number (1-800-772-1213) or your local Social Security office, to make an appointment to apply for your benefit as your husband's widow.

And to answer vour last question, your state pension won't affect your monthly Social Security

payments because you paid Social Security FICA payroll taxes from your municipal earnings.

DEC: Use local firewood this camping season

Many people like to take firewood from their homes before traveling to a campsite. Invasive pests like the emerald ash borer or Asian longhorned beetle often hitch a ride to new areas in untreated firewood. Transport of untreated firewood across the state has caused outbreaks of these damaging pests.

Since 2009, New York state has regulated the movement of firewood to help control the spread of untreated firewood for invasive species and diseases. Untreated firewood must have been grown in New York and cannot be moved more than 50 miles from where it was grown or its source

Producers of firewood for sale are allowed to declare their business as the source provided the wood was grown within 50 miles of their business and they must maintain documentation. Those moving their own use must fill out a Self-Issued Certificate of Origin.

Treated firewood, which has been heated to a core temperature of 160-degrees Fahrenheit for 75 minutes and labeled as "New York Approved Heat-treated Firewood/ Pest Free," can be moved without restrictions.

DEC has an interactive map that shows if firewood's source and its destination are within 50 miles

Violation of firewood regulations can result in fines, penalties and the potential destruction of beloved trees and habitats.

The safest way to enjoy a campfire and protect New York forests is to buy and burn local firewood at your destination. Read more about New York's firewood regulations on DEC's website at dec.

"I don't have time" is the most common excuse people make when they want to avoid doing something like exercise. Between work, kids and other responsibilities, our

24/7 lifestyle often leaves but now all fitness levels us feeling like there just isn't enough time to squeeze exercise in. Or is there?

Today's post describes how you can turn your body into a fat-burning machine and reap tons of other benefits in as little as 15 minutes a day with

High-Intensity Interval Training (HIIT) combines short, high-intensity bursts of exercise with slow recovery phases repeated throughout one short 15-30 minute session. At one time only elite athletes used HIIT, are doing it, enjoying the same benefits and achieving amazing results with little or no equipment.

Not sure you believe it? Well, there's tons of research available proving that high-intensity interval training is more effective than a 60-minute routine, making it an ideal fit for your busy schedule or if you must get in shape for a fast-approaching event!

And HIIT is so effective that even the World Health Organization recommends it!

So ditch your old workout routine and try something new. There are plenty of free online apps like J & J Official 7-Minute Workout and Workout for Women. Both sites offer plenty of workout variations for beginners to advanced athletes.

How to identify giant hogweed



The giant hogweed is an invasive species that can cause painful burns

Giant hogweed plants are beginning to bloom across many parts of the

state, making it a prime time to spot this harmful invasive species.

Giant hogweed is a large, flowering plant from Eurasia with sap that can cause painful burns and scarring.

Adult giant hogweed plants tend to be 7-14 feet tall with an umbrella-shaped cluster of white flowers up to 2.5 feet wide. The stem is green with purple splotches and coarse white hairs, and the leaves are large (up to 5 feet across), incised, and deeply lobed.

The most common lookalike found in New York is our native cow parsnip, which flowers earlier and does not have the purple splotches on the stem (but can also cause burns). You can find more identification tips, including a table of other lookalikes, on the DEC website at dec.ny.gov.

If you think you have found giant hogweed:

• Do not touch it. · From a safe distance, take photos of the plant's stem, leaves, flowers, seeds, and the whole

• Report your sighting to the DEC by emailing photos and location information to ghogweed@ dec.ny.gov or by calling 845-256-3111. DEC staff will help you confirm if it is giant hogweed and provide you with information on how to control it.

Study outlines role of manufactured homes in **NYS** housing crisis

ALBANY – More than 20 million Americans live in manufactured housing, according to the U.S. Census Bureau. That's more than in public housing and federally subsidized rental housing combined.

Since manufactured homes make up a significant part of the nation's housing stock and provide a viable affordable housing option, the Rural Housing Coalition of New York (RHC) contends manufactured homes should play a larger role in discussions, policies and plans to address the ongoing housing shortage, according to the organization.

The Rural Housing Coalition commissioned a report titled "The Role of Manufactured Housing in New York's Affordable Housing Crisis" that lays out policy recommendations based on 30 years of data collected from 1989

"There are 192,890 manufactured housing units in New York state making up 2.4% of the state's total housing stock," said Mike Borges, executive director of the Rural Housing Coalition. "However, in rural areas, that percentage jumps to 10.3% of housing stock more than 100,000 manufactured housing units. The report identifies Saratoga, Dutchess and Ulster counties as having the concentrations highest of manufactured housing communities in the state."

The study was funded by a grant from Enterprise Community Partners and completed by the Center for Impact Finance at the University of New Hampshire. The report gleaned data from existing public documents to inform policymakers on the conditions, locations and demographics of Manufactured Housing Communities (MHCs) in New York

state. recommenda-Top tions of the report were:

• Better enforcement and compliance with existing laws and regulations regarding the registration of manufactured housing communities with the NYS Department of Taxation and Finance.

· The research uncovered a significant decline in mobile home park registrations in recent years - but the parks are still there. Until 2019, NYS Housing and Community Renewal (HCR) managed the registration of these parks, but in 2020, the NYS Department of Taxation and Finance took on the task of managing park registrations. The report showed that the "number of registered parks has declined from 1,800 to 1,200" – and that information is missing on about one-third of the manufactured home communities in New York.

 Legislation to support expanded opportunities for residents to purchase their manufactured communities housing in the case of sale of the property regardless of any change of use.

• The rights of manufactured homeowners who rent space in a manufactured home park in New York State are covered under Section 233 of the Real Property Law, also known as the "Manufactured Homeowners Bill of Rights." At the end of the 2023 session, the NYS Legislature passed a measure to give manufactured homeowners the right of first refusal when the park in which they live is put up for sale regardless of land use changes. The bill will be sent to Governor Hochul for consideration.

Legislation would foster and fund the purchase of development rights of manufactured housing communities using open space and farmland conservation programs as a model.

 Across New York State – and the country – large national investment firms are buying up mobile home parks, dramatically raising fees, and evicting people who can't pay the lot rent, even though they own their homes. To help preserve locally owned MHCs as an affordable

housing option, the report calls for the creation of a state-funded program to offset the cost of purchasing the development rights of MHCs. Successful programs to preserve open space and farmland could serve as a model.

 Increase mortgage recording taxes on MHC sales to for-profit entities to establish a resident displacement fund.

· When a manufactured home community is sold, residents can't easily move their homes, even if they can find an alternative site. Accordingly, many people are forced to abandon their homes and start from scratch. The report proposes increasing mortgage recording taxes on MHC sales to for-profit entities to establish a resident displacement fund.

· Help low- and moderate-income homeowners replace dilapidated manufactured homes.

• The report calls for an increase in funding for the Mobile and Manufactured Home Replacement Program administered by HCR from the current \$5 million to \$10 million, and an increase on the amount allocated per home from \$100,000 to \$200,000.

"As state policymakers continue to tackle the affordable housing shortage in New York, we urge them to work toward a solution that addresses the needs of the whole state and not just downstate," Borges said. "That solution should include ways to preserve manufactured housing communities as an affordable housing option."

The Rural Housing Coalition of New York is a statewide organization dedicated to revitalizing rural New York by strengthening housing and community development providers. The coalition supports rural housing and community development providers through organizational capacity development, training and technical assistance, and raising public awareness and advocacy.

DEC seeks reports of moose sightings



The state DEC is asking the public to report moose sightings and be vigilant on the roads.

The Department of Environmental Conservation is asking the public to report moose sightings via an online form as part of ongoing efforts to monitor moose distribution across New York.

While the Adirondacks are home to most New York moose, some live in the eastern part of the state along the Vermont and Massachusetts borders. Moose can also occasionally be found in southeastern New York and the Catskills, but these are usually individuals that have dispersed from other areas.

Moose are the largest

land mammal in the state. In the summer, when most sightings occur, moose typically spend a lot of time in ponds and wetlands feeding on submerged aquatic plants. During the rest of the year in cooler weather, they browse on leaves, twigs and buds of trees and shrubs. Favored browse species include willows, birches, maples, balsam fir, viburnums, aspen and mountain ash.

Bulls weigh up to 1,200 pounds and stand up to 6 feet tall at the shoulder. Cows weigh anywhere from 500 to 800 pounds and usually give

birth to one or two calves in late May or early June.

Many moose sightings occur along roadways. Drive cautiously at dusk and dawn as moose can be hard to spot due to their dark color. If you see a moose, do not block traffic, and remember to respect wildlife by keeping quiet and viewing from a

AG warns about e-bike safety

NEW YORK - New York Attorney General Letitia James last week warned New Yorkers of the dangers caused by electrical bike (e-bike) batteries and provided tips on how to safely handle them.

The alert comes in light of a deadly fire that killed four individuals at an e-bike repair shop in Manhattan's Chinatown last week.

Most e-bikes, as well

as e-scooters and hoverboards, use powerful lithium-ion batteries that store more energy and are more likely to catch fire than a typical battery. In 2022, there were at least 220 fires and six deaths as a result of lithium-ion batteries from e-bikes and other devices in New York City alone. This year, these batteries have caused at least 108 fires and resulted in 13

"E-Bikes can be great tools, but also can pose significant risks to New Yorkers and their families," James said. "The best way to protect our loved ones from the risks associated with e-bikes is to handle these devices and their batteries carefully and follow all safety precautions. As we continue to mourn the lives of those we lost in this week's fire, I urge everyone to take all neces-

sary steps to avoid future e-bike-related tragedies."

In September 2022, James issued a consumer alert about the dangers posed by e-bike batteries, and noted that when proper precautions are taken when buying, storing, charging and disposing of these batteries, accidents can be avoided.

James recommended consumers take the following steps when using

- Buy your e-bike and battery from a trusted manufacturer.
- · Maintain your battery by carefully checking it from time to time. If you notice any strange smells or changes in shape or color, stop using the battery immediately and contact your local fire station or call 911.
- Store your battery in a safe place.
- Charge your battery using only the cord and power adapter provided by the manufacturer.
- Dispose your battery at a battery-recycling location. Do not reuse or refurbish used lithium-ion batteries or its parts.
- Note: Putting batteries in the trash or recycling them is both dangerous and illegal, and can lead to fires on sanitation trucks and in recycling facilities.
